Baseball Queensland Life Membership Nomination

To all Regions and Baseball Queensland Board Members,

Brisbane South would like to nominate Kevin Cantwell for Life Membership with Baseball Queensland. Kevin has had a long history in the game of baseball both as a player and as an on-field instructor and he can still be seen on the diamond assisting with the High Performance and State Team Programs. His involvement in baseball began in 1947, spanning over 74 years.

Kevin began his playing career in Sydney and began his 'A Grade' career at the age of 16. After a few short years as a stand out club baseball player, Kevin gained selection to the NSW Claxton Shield. He was a regular selection from the late 1950's and into the early 1970's. He was awarded the "Helms Award" for the MVP of the Claxton Shield held at Bannister Park in 1963. Kevin was also a long-term player on the National team during his playing career. As you can imagine, there are many details of his esteemed playing career that have not been noted.

Towards the end of Kevin's playing career, he began to become involved in the coaching side of the game. He continued as a player-coach at a high level, but when he was approached to coach in Queensland, he jumped at the chance. He became involved at All-Stars and coached the Queensland Claxton Shield team for a number of years from 1974. During his time as a Claxton Shield Coach, he also was appointed to the National Team that played against Japan and U.S.A.

Kevin has maintained his involvement in the development and mentoring of many players over the last 50 years. He has continued to coach players at a club, state level and National level. Kevin was one of the most highly credentialed coaching group at the successful Major League Baseball Australia Academy Program (MLBAAP) that took place for over 15 years. Kevin has been a regular face at the BQ High Performance Programs over the last number of years. You can usually see him assisting Shayne Watson and other Baseball Queensland coaches on a Sunday morning in his BQ uniform.

Kevin's leadership, coaching style and ability to create and maintain positive relationships led to the establishment of his own Masters baseball team. This team attracts high calibre players from all around Australia who love to be coached and involved in "Crazy's Interport" team. These teams not only play in the various competitions but also run clinics to get the game of baseball out into the community. Kevin has continued to coach Masters for over 28 years.

As a result of Kevin's stellar playing, career, coaching career and for his enormous input to the game, Kevin was inducted into the Australian Baseball Hall of Fame in 2005.

To this day, Kevin continues to advocate for baseball to a wide audience. Kevin is highly regarded in the extended Australian sporting world and he travels Australia as guest speaker. Anyone who has had the opportunity to speak with 'Craze' will know that there is always an entertaining story to be heard.

Kevin Cantwell is a long serving and well-respected member of the Australian Baseball community. Since 1973, 'Crazy' has been a servant of the game and an outstanding representative of Baseball in Queensland. It is the belief of the members of Brisbane South Baseball Association, that Kevin Cantwell is worthy recipient of Life Membership to Baseball Queensland.
